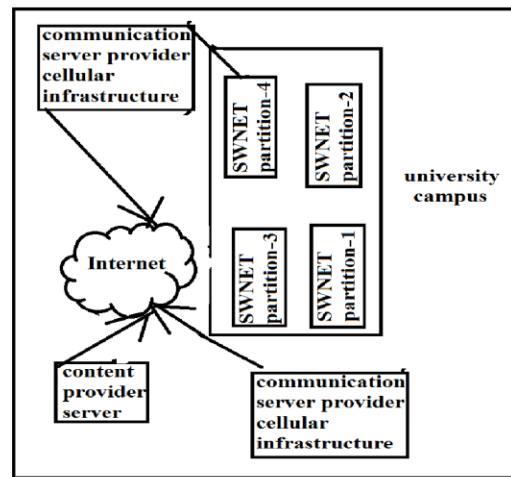


Fig1: An over view of content access from an SWNET
