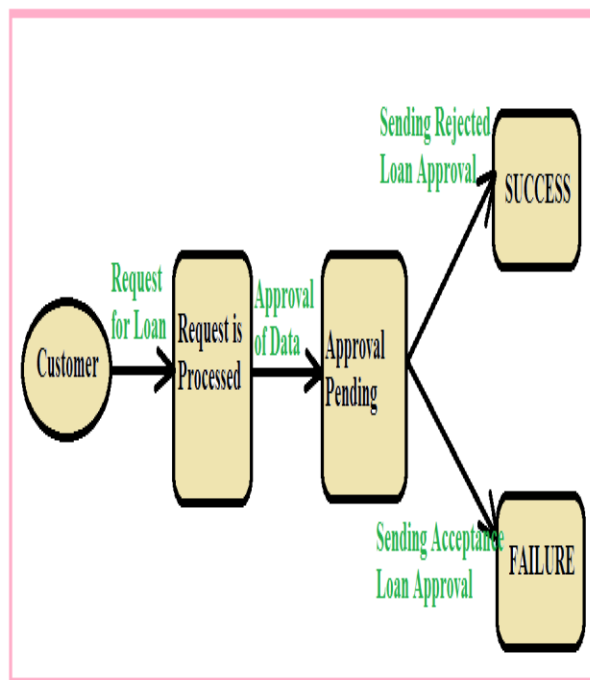


Fig 1: loan approval process
