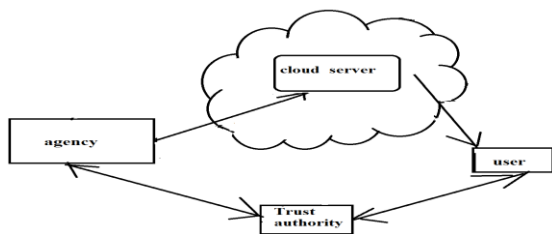


Fig1: An overview of System construction for CAM
